OTTAWA - The Ottawa Police Services Board is pleased to announce that it has selected Edward (Ed) Keeley, currently Executive Officer and Superintendent – Office of the Chief Directorate, as Deputy Chief of the Ottawa Police Service. Board Chair and City Councillor Eli El-Chantiry stated, "Deputy Chief-Designate Keeley is very well respected by members of the Police Service and is an advocate for accountability, trust and transparency to the community. These traits and his commitment to the Police Service will assist him in supporting Chief Bordeleau and in providing leadership within the organization and in the community." Chief of Police Charles Bordeleau added, "Supt.
